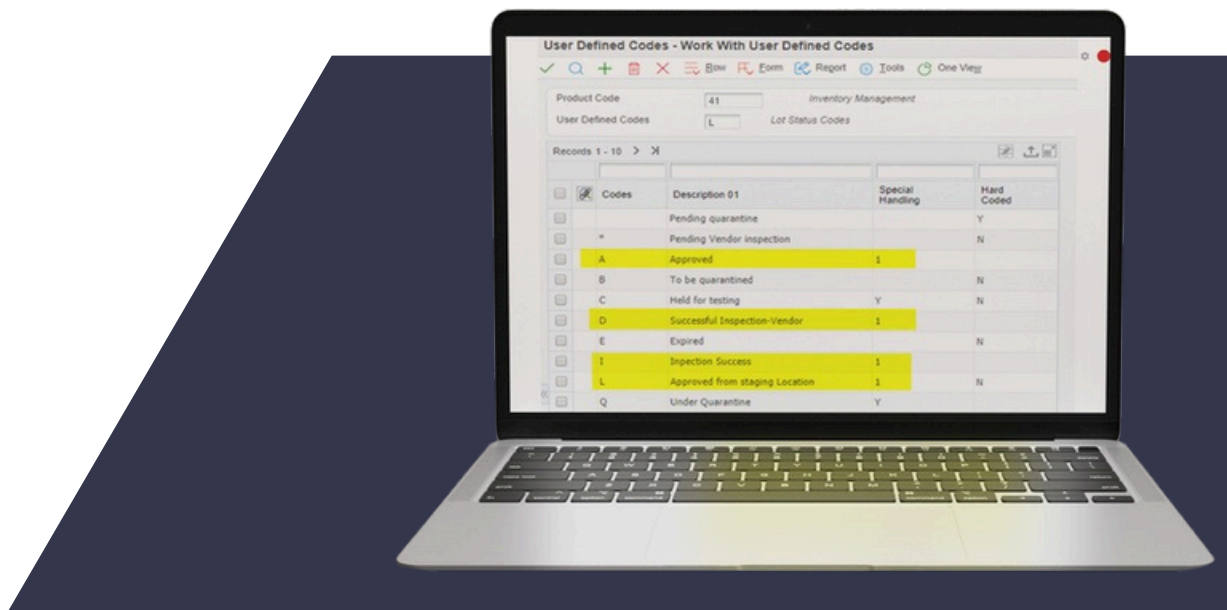
# Mejoras de las últimas versiones

## Inventarios

### Posibilidad de usar varios estados de lote como Aprobados

Previamente solo el estado de lote “en blanco” permitía operar. Los demás estados se consideraban retenidos.

Actualmente, se pueden definir otros estados como aprobado.



### Posibilidad de bloquear una ubicación completa

Previamente restringir:

- Solo movimientos de ingreso
- Solo movimientos de egreso de todos los movimientos





## Cuentas por pagar

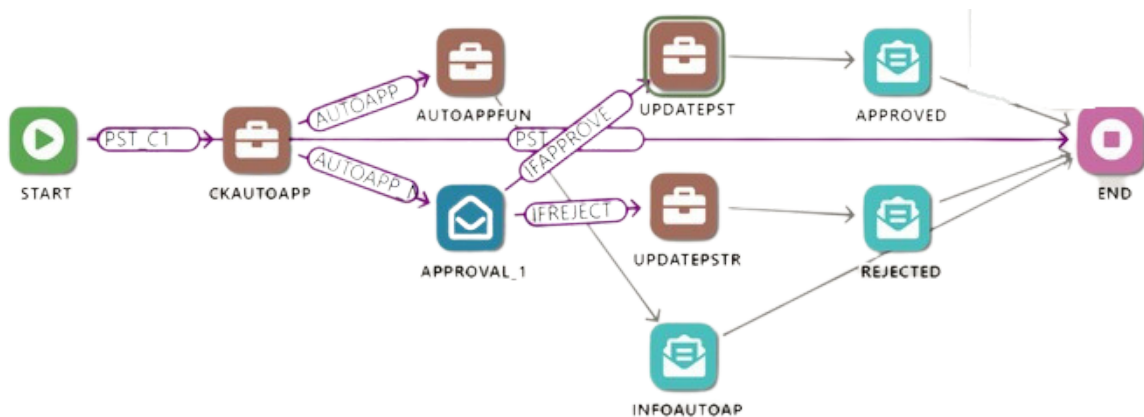
### Workflow aprobación comprobantes

Carga de comprobantes:

- Comprobación de límite
- Mail al aprobador
- Estado de pago "Y"  
(workflow en proceso)

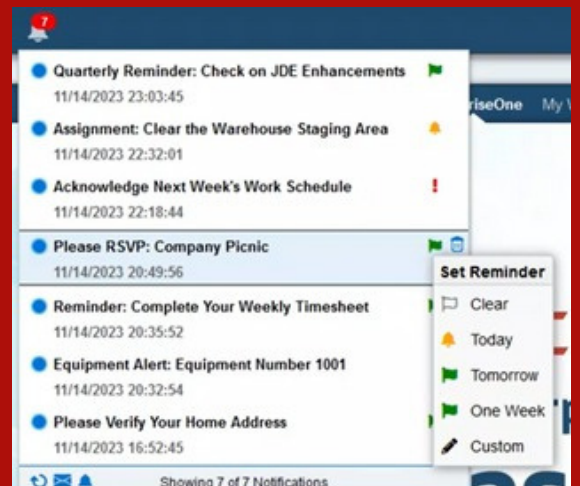
Aprobación / Rechazo:

- Mail al originador
- Estado de pago "A" o "F"  
(workflow rechazado)



## Recordatorios de notificaciones

- Notificaciones por mail, work center, o en JDE.
- Se permite agrupar, postergar, y configurar notificaciones.
- Posibilidad de pop up de notificaciones en el navegador.



## Workflow Monitor

Permite controlar el estado de los workflows:

- Validación de ejecuciones correctas
- Manejo de errores y excepciones
- Análisis de métricas



## Table from data set in notification or message component (Release 24 - 9.2.8.3)

Esta funcionalidad extiende las capacidades que tienen las notificaciones y componentes de mensajes. Permite ver la salida de una orquestación o extensión lógica en forma de tabla. Esta característica facilita la presentación de la información al usuario, reduce los tiempos de análisis y permite tomar decisiones de forma más rápida. También, permite insertar tablas editables a partir de un data set.
